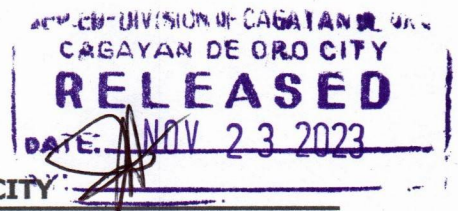

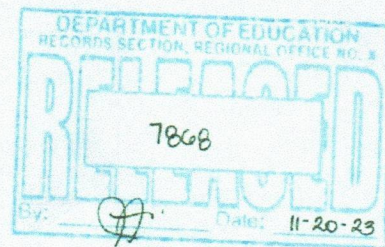
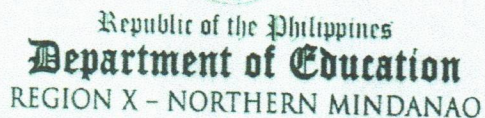

Consistent with Republic Act No. 11510, or the Alternative Learning System (ALS) Act, which highlights the partnerships with government agencies on the implementation of ALS programs, this Office, through the Curriculum and Learning Management Division (CLMD), will conduct a **Regional Capacity Building of the Bureau of Jail Management and Penology (BJMP) Personnel in the Delivery of ALS Programs Inside Jail Facilities** in Cagayan de Oro City, on December 6-8.
