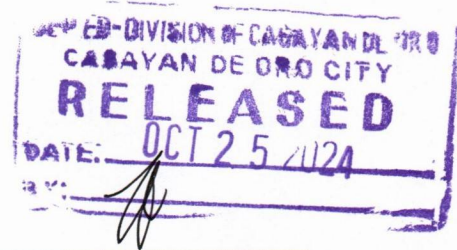

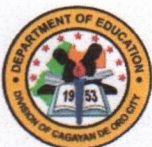

ADDENDUM TO DM 808, s. 2024 RE: PARTICIPATION TO NAVIGATING
WELLNESS: CLUSTERED REGIONAL SYMPOSIUM ON CHILD AND
ADOLESCENT REPRODUCTIVE HEALTH (CARH)

1. Additional participant to attend the conduct of Navigating Wellness: Clustered Regional Symposium On Child And Adolescent Reproductive Health (ARH) to be held in Ritz Hotel Porras Street, Davao City on November 4-8, is EDSLYN L. This may likewise applicable to situations when attending personnel needs to travel a day before the opening (Sunday) or a day after the closing (Saturday) due to the availability of flights or if activity falls within a national or local holiday.
5. All other provisions in the previous memorandum remain in effect.

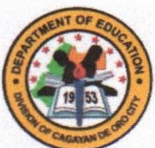
